### **Primacy of ISO and IEC standards**

CEN and CENELEC's commitment to international standardization gives Europe **greater alignment** with international standards.

**72%** of CENELEC standards are identical.

33% of CEN standards are identical.

### The European Standardization System boosts European competitiveness

The European Standardization is **highly innovation friendly** and **market-driven**.

The single standards model avoids fragmentation in the market.



European standards facilitate compliance with the EU harmonization legislation and hence the entry and free circulation of goods in the EU Single Market; based on a set of requirements equally applicable in all Member States of the European Union.

### **European Standardization addresses evolving market needs**

# Case Study: Eurocodes boost growth across Europe and beyond



They are the Europe-wide standards for all aspects of the structural design and development of buildings.

Designed to break down technical barriers to trade across Europe and beyond, Eurocodes provide a common language for owners, operators, users, designers, contractors and manufacturers, giving a common basis for R&D, design aids and software. They are also the mandatory standards for public procurement projects in the UK.
